The nominee will be an Office Bearer/Ordinary Committee Member of Monaro Panthers FC Inc. The Office Bearers are President, Vice President, Secretary, Treasurer and 3 ordinary Committee Members.

Office Bearers/Committee Members should bring skills, know-how and professional standards to the Association. A person cannot be an Office Bearer/Committee Member if they are or become bankrupt or a represented person. In line with Monaro Panthers FC Inc. being a not-for-profit Association, Office Bearers/Committee Members are a voluntary position, will receive no remuneration. Office Bearers/Committee Members will be covered under Monaro Panthers FC Inc. insurance, and a copy of the Policy is available upon request. Office Bearers/Committee Members should declare any known or potential conflict of interest, and absent himself or herself from a General Meeting if a conflict of interest arises.

Office Bearers/Committee Members are required to attend General Meetings, of which there are typically ten (10) per calendar year. General Meetings are typically held outside of normal working hours, and typically held at the Riverside Clubhouse in Queanbeyan.

From time to time, Office Bearers/Committee Members may be required to attend Meetings outside of General Meetings, which may include sub-committees, game day matches, disciplinary tribunals, fundraising events and other events deemed appropriate by the Committee.

If more Office Bearer/Committee Member Nomination Forms are received, than places available, the nominees may be required to make a short statement at the AGM, and then contested offices shall be subject to ballot of the members present in person.
